I am directed to say that it is proposed to fill up the post of Director General in the Competition Commission of India (DG, CCI) at its headquarters at New Delhi, under the administrative control of this Ministry. The particulars of the post, scale of pay, and the eligibility requirements, are set out in Annexure-I.

- The person to be appointed as Director General shall be a person of integrity and outstanding 2. ability with experience in investigation, and knowledge of accountancy, management, business, public administration, international trade, law or economics.
- The person selected will be appointed on deputation basis. Pay will be regulated in accordance with the Department of Personnel & Training's OM No. 2/29/91-Estt. (Pay-II) dated 05.01.1994, as amended from time to time. The period of deputation including the period of deputation in the same or some other organization/department of the Central/State Government shall not ordinarily exceed three years as prescribed in para 8.1 of the instructions issued by DoP&T in this regard vide their OM No. 6/8/2009-Estt. (pay-II) dated 17.06 2010. The maximum age limit for appointment on deputation basis is 56 years on the closing date of submission of applications.
- The terms and conditions of the incumbent of the post of DG, CCI will be regulated by Competition Commission of India (Number of Additional, Joint, Deputy or Assistant Director General other officers and employees, their manner of appointment, qualification, salary, allowances and other terms and conditions of service) Rules, 2009, as amended from time to time.
