Subject: Preparation of panel for appointment of officers on loan/local transfer basis in the Cadre of Senior Intelligence Officer & Intelligence Officer in the Directorate General of GST Intelligence, Agartala Regional Unit, Imphal Regional Unit, Aizawl Regional Unit and Dimapur Regional Unit under Guwahati Zonal Unit - Regarding.

Directorate General of GST Intelligence, Guwahati Zonal Unit is in the process of drawing up a panel of willing and suitable officers for filling up the posts of Sr. Intelligence Officer & Intelligence Officer at Agartala Regional Unit, Imphal Regional Unit, Aizawl Regional Unit and Dimapur Regional on loan/local transfer basis. The existing vacancies in the above are enumerated as below:

2. It is proposed to fill up these vacancies by appointing suitable officers from respective grades of officers of Central Tax & Customs respectively **on loan basis.**

3. Normally, the posting on loan basis is for a period of two years, which may further be extended for one year, subject to willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority.


4. During the period of posting on loan basis, the pay and other allowances of the concerned officer(s) shall be drawn from their respective parent Commissionerate(s).

5. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may be furnished for evaluation by this Directorate.

- i) Complete Bio-data and willingness letter of the officer alongwith history of previous postings;
- ii) ACR / APAR gradings for the last (5) five years duly verified and attested by the Additional / Joint Commissioner (P&V);
- iii) Vigilance Clearance Certificate; and
- iv) No Objection Certificate from the Cadre Controlling Authority to relieve the Officer in the event of his / her selection.
