The Directorate General of Goods & Service Tax Intelligence, Visakhapatnam Zonal unit is in the process of drawing a panel of willing and suitable officers for filling up the following vacancies, both ministerial and executive cadres, on loan basis in Visakhapatnam Zonal Unit and its regional unit located at Vijayawada as under:

2. It is proposed to fill up the above vacancies by appointing willing and suitable officers on loan basis for a period of two years, from the corresponding grades of Superintendent (for the post of Sr. Intelligence Officer) / Inspectors (for the post of Intelligence Officers) / Administrative Officer / Tax Assistants / Head Hawaldars / Hawaldars / Drivers working in various formations of CBIC.

3. It may be made clear to the willing officers that the option once given would be final and in the event of their selection, he / she will not be allowed to withdraw the same. It is also made clear to the officers that no residential accommodation is arranged by the Directorate and that the appointment is purely on loan transfer basis and no deputation allowance or other special allowances are paid for working in DGGI. Further, their continuation in DGGI is subject to their suitability and performance and they can be repatriated to their parent formations at any time before completion of their two years tenure, in case they are found to be not suitable for DGGI at any point of time.

4. It is requested that this circular may be brought to the notice of all the formations under your jurisdiction and the applications of willing and eligible officers may be forwarded to this Zonal Unit by 15.01.2019. While forwarding the names of the willing officers, the following information in respect of him / her may also be sent for evaluation by this Directorate

- i) Complete Bio-data and willingness of the officer.
- ii) History of posting.
- iii) 'No Objection Certificate' from Chief Commissioner's Office to relieve in the event of his / her selection.
- iv) APAR grading for the last 5 years.
- v) Vigilance Clearance Certificate.
