**Subject: Preparation of panel for the appointment of Senior Intelligence Officer in the Adjudication Branch of Directorate General of Goods & Services Tax Intelligence (Headquarters), New Delhi in the Pay Level-8 of Rs.47,600-Rs.-1,51,100 as per the 7<sup>th</sup> CPC (Pre-revised Pay Band-II of Rs.9300 – Rs.34800 + Grade Pay of Rs.4800 of the 6<sup>th</sup> CPC)-C/Regarding.**

The Directorate General of Goods & Services Tax Intelligence (Headquarters), New Delhi is in the process of drawing a panel of willing and suitable officers in the grade of Senior Intelligence Officer for their appointment in Adjudication Branch of Directorate General of Goods & Services Tax Intelligence (Headquarters), New Delhi. It is proposed to fill up 02(Two) vacant posts of Senior Intelligence Officer by appointing willing and suitable officers on deputation basis from the grade of Superintendent of CGST, Central Excise & Customs. The officers who have been granted financial up-gradation under MACP Scheme, are also eligible to apply.

2. The selected officers, while being posted in the Directorate General as Senior Intelligence Officers, will be entitled to admissible special allowance in terms of Government of India's instructions issued from time to time. Normally, the deputation is for a period of five years, which is extendable by another two years, one year at a time, subject to the willingness of the officer, his/her performance, concurrence of his/her parent Commissionerate and approval of the Competent Authority.


3. It may also be mentioned here that the option for deputation to DGGI, once exercised, cannot be withdrawn under any circumstances.



4. It is requested that the circular may please be brought to the notice of all the formations under your jurisdiction and the applications of the willing officers may be forwarded to this Directorate General. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate General:-

- (i) Complete Bio-data and willingness of the officer along-with history of postings;
- (ii) List of cases booked on his own information/intelligence along with duty /case involved and recovered;
- (iii) Details of work experience in Adjudication related matters;
- (iv) APAR gradings for the last 5 years including the year 2017-18 {Duly verified and attested by the Addl./Joint Commissioner (P&V)};
- (v) Vigilance Clearance; and
- (vi) No Objection Certificate from the Cadre Controlling Authority to relieve the officer in the event of his/her selection.
