Subject: Preparation of panel for appointment in EA/STA/TAs grade in DRI Ludhiana Zonal Unit and its Regional/Sub-Regional Units on loan basis- reg.

The Directorate of Revenue Intelligence, Ludhiana Zonal Unit (DRI, LdZU) is in the process of drawing a panel of suitable candidates for appointment of officers on loan basis in the following grades:

2. It is proposed to appoint candidates on loan basis from amongst the staff in equivalent grade in Customs and GST (Govt. of India) / Central Excise.

3. Normally, the loan tenure is for a period of two years. It may be made clear to the willing candidates that the option once exercised would be final and in the event of selection, they will not be allowed to withdraw the same.

4. Pay and allowances of the staff posted on loan basis in this Directorate shall be drawn and paid by the parent Commissionerates.

5. It is requested that the circular may be brought to the notice of all the formations in your jurisdiction and the applications of willing candidates may be forwarded to this office. While forwarding the names of willing candidates, the following information may also be sent for evaluation by this Directorate:

(i) Bio-data and willingness of the candidate along with history of previous posting.

(ii) No objection Certificate from Chief Commissioner to relieve in the event of his selection.

(iii) ACR grading for the last upto 3 years duly verified and attested.

(iv) Vigilance Clearance Certificate.
