1. Administrative Changes:-

- Order regarding placing of services of Shri Chanderpal Singh Chauhan, Joint Commissioner at the disposal of Department of Commerce on deputation basis for a period of 04 years, has been issued vide Office Order No. 123/2019 dated 05.09.2019.
- Order regarding transfer and posting in the grades of Assistant Commissioner of Customs, GST and Central Excise, has been issued vide Office Order No. 124/2019 dated 05.09.2019.
- Order regarding transfer and posting in the grade of Chief Commissioners/Director Generals of Customs, GST and Central Excise, has been issued vide Office Order No. 125/2019 dated 06.09.2019.

2. Legislative Changes:-

- Notification No. 29/2019-Cus, dated 04.09.2019 has been issued to further amend Notification No. 53/2011 dated 01.07.2011, to increase the rate of duty of Customs by 5 percent, for a period of 180 days, on imports of RBD Palmolein/Palm Oil originating in Malaysia and imported under India-Malaysia Comprehensive Economic Cooperation Agreement, on recommendation of preliminary findings of Directorate General of Trade Remedies under India-Malaysia Comprehensive Economic Cooperation Agreement (Bilateral Safeguard Measures) Rules, 2017.
- Notification No. 34/2019-Cus (ADD), dated 06.09.2019 has been issued to amend Notification No. 2/2016-Customs(ADD), dated 28.01.2016, in pursuance of New Shipper Review final findings issued by DGTR.
- Notification No. 35/2019-Cus(ADD), dated 06.09.2019 has been issued to rescind Notification No. 11/2018-Customs(ADD), dated 20.03.2018, in pursuance of New Shipper Review final findings issued by DGTR.
