- A consolidated Order regarding allocation of work among Members of CBEC has been issued vide Office Order No.175/2015 dated 28.12.2015.
- Order regarding postings/transfers of 3IRS(C&CE) officers in the grades of Joint Commissioner of Customs and Central Excise has been issued vide Office Order No.176/2015 dated 30.12.2015.
- Order regarding promotion on regular basis to the grade of Chief Accounts Officer(Customs) Group 'A' GCS (Ministerial) in CBEC has been issued vide Office Order No.5/2015 dated 31.12.2015.
