1. Administrative Changes:-

- Order regarding Non-Functional Up-gradation of 24 IRS(C&CE) officers in the grade of Principal Commissioner of Customs and Central Excise (HAG) in the pay scale of Rs. 67,000-79,000 has been issued vide Office Order No. 50/2016 dated 02.05.2016.
- Order regarding partial modification in the chain of nominated link officers in the grade of Chief Commissioner of Customs and Central Excise has been issued vide Office Order No. 45/2016 dated 26.04.2016.
