**1. Administrative Changes:-**

- Order regarding cancellation of the loan postings orders of IRS (C&CE) Group 'A' i.e. office order No. 17/2019 dated 05.02.2019, has been issued vide Office Order No. 32/2019 dated 05.03.2019.
- Order regarding promotion of IRS (C&CE) Group A officer to the grade of Joint Commissioner, has been issued vide office Order No. 33/2019 dated 06.03.2019.
- Order regarding transfer/postings in the grade of Deputy Commissioner/Assistant Commissioner, has been issued vide Office Order No. 34/2019 dated 07.03.2019.

**2. Legislative Changes:-**

- Notification No. 02/2019-Central Tax(Rate), dated 07.03.2019 has been issued to give composition scheme for supplier of services with a tax rate of 6% having annual turnover in preceding year upto Rs 50 lakhs.
- Notification No. 02/2019-Union Territory Tax (Rate), dated 07.03.2019 has been issued to give composition scheme for supplier of services with a tax rate of 6% having annual turnover in preceding year upto Rs 50 lakhs.
- Notification No. 01/2019-ST, dated 06.03.2019 issued for exempting services provided by project implementation agencies under the Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDUGKY) for the period commencing from the 01.07.2012 and ending with the 29.02.2016.
