**1. Administrative Changes:-**

- Order regarding transfers/postings of 190 IRS(C&CE) officers in the grades of Deputy/Assistant Commissioner of Customs and Central Excise on ad-hoc has been issued vide Office Order No. 53/2016 dated 10.05.2016.
- Order regarding transfers/postings of 145 IRS(C&CE) officers in the grades of Additional/Joint Commissioner of Customs and Central Excise on ad-hoc has been issued vide Office Order No. 54/2016 dated 10.05.2016.
- Order regarding granting of extension of further three months in the loan period of Shri Anuj Gogia, Additional Director General with Enforcement Directorate has been issued vide Office Order No. 55/2016 dated 10.05.2016.
