Based on the inputs received from various sections, following is the compilation of the important developments for the week –**13.06.16 to 17.06.16.**

**1. Administrative Changes:-**

- Order regarding assigning of additional charge to Members of Central Board and Excise has been issued vide Office Order No. 70/2016 dated 15.06.2016.
- Order regarding placement of services of Shri Raman Kumar Mehta, IRS at the disposal New Delhi Municipal Council(NDMC) for the post of Director has been issued vide Office Order No. 68/2016 dated 15.06.2016.
- Order regarding appointment of Ms. Anurima Sharma, IRS and Shri Anand Kumar Jha, IRS as OSDs in CBEC has been issued vide Office Order No. 69/2016 dated 15.06.2016.
- Order regarding posting of Shri Nikhil Chandra, Additional Commissioner of Central Excise to Delhi ST has been issued vide Office Order No. 71/2016 dated 15.06.2016.

**2. Legislative Changes:-**

- Notification No. 26/2016-Cus(ADD), dated 13.06.2016 has been issued to extend the levy of anti-dumping duty on imports of Pentaerythritol, originating in, or exported from the People's Republic of China, for a period of one year.
- Notification No. 37/2016-Cus, dated 16.06.2016 has been issued to further amend notification No. 27/2011-Customs, dated 01.03.2011 so as to impose export duty of 20% on raw sugar, white or refined sugar.
- Notification No. 38/2016-Cus, dated 17.06.2016 has been issued to further amend notification No. 12/2012-Customs, dated the 17th March, 2012 so as to continue with the imposition of BCD of 25% on wheat beyond 30.06.2016 and without an end date.
- Notification No. 24/2016-CE, dated 14.06.2016 has been issued to further amend notification No.214/86-Central Excises dated 25.03.1986.
- Notification No. 25/2016-CE, dated 14.06.2016 has been issued to further amend notification No.67/95-Central Excises dated 16.03.1995.
- Notification No. 84/2016-Cus(N.T.) dated 14.06.2016 issued to appoint Common Adjudicating Authority in the cases investigated by DRI reg.
