1. Administrative Changes:-

- Order regarding additional charge of Bengaluru Customs Zone to Shri D.P. Nagendra Kumar, in addition to his regular charge of Pr. Chief Commissioner, Bengaluru GST & CX Zone w.e.f. 30.09.2019 vice Shri Abhay K. Jyotishi, Chief Commissioner, consequent upon his superannuation, & Additional Charge of Delhi of Delhi GST & CX Zone to Shri Sandeep Kumar, in addition to his regular charge of Director General, DGARM, Delhi w.e.f. 30.09.2019 vice Shri Sunil Kumar Sawhney, Pr. Chief Commissioner consequent upon his superannuation, has been issued vide Office Order No. 119/2019 dated 28.08.2019.

- Notification No. 38/2019-Cus (ADD), dated 25.09.2019 has been issued to impose anti-dumping duty on imports of 'High Speed Steel of Non-Cobalt Grade' originating in, or exported from Brazil, China and Germany.
- Notification No. 39/2019-Customs(ADD), dated 28.09.2019 has been issued to rescind Notification No. 23/2013-Customs(ADD) dated 10.10.2013, in order to rescind anti-dumping duty on 'Ductile iron pipes' originating in, or exported from China PR.
