Based on the inputs received from various sections, following is the compilation of the important developments for the week –28.05.18 to 01.06.18.

**1. Administrative Changes:-**

- Order regarding posting/ transfer of 04 (four) IRS (C&CE) Group A officers, has been issued vide Office Order No.87/2018 dated 31.05.2018.
- Order regarding posting of 02 IRS (C&CE) Group A officers to Directorate General of Systems and Data Management on loan basis, has been issued vide Office Order No.88/2018 dated 01.06.2018.
- Order regarding grant of ante-dated promotion to Shri P.K. Bamania in the grade of Assistant Commissioner of Customs and Central Excise on ad-hoc basis, has been issued vide Office Order No.89/1018 dated 01.06.2018.
- Order regarding grant of ante-dated promotion to Dr.Srikant Kumar Mohapatra, in the grade of Assistant Commissioner of Customs and Central Excise on ad-hoc basis, has been issued vide Office Order No.90/2018 dated 01.06.2018.
- Order regarding grant of pro forma promotion to 04 (four) IRS (C&CE) Group A Officers under Next Below Rule (NBR) on 'one to one basis', has been issued vide Office Order No.91/2018 dated 01.06.2018.

- Notification No. 30/2018-Cus (ADD) dated 30.05.2018 issued for providing provisional assessment of jute goods exported from Bangladesh or Nepal by M/s Janata Jute Mills Ltd.(Producer) till the final findings of New Shipper Review in this regard are received.
- Notification No. 31/2018-Cus (ADD) dated 30.05.2018 issued for providing provisional assessment of jute goods exported from Bangladesh or Nepal by M/s. Aman Jute Fibrous Ltd. (Producer) and M/s IB Jute Corporation (Exporter/Trader) till the final findings of New Shipper Review in this regard are received.
- Notification No. 32/2018-Cus (ADD), dated 01.06.2018 has been issued to rescind Anti-Dumping Duty on imports of the Digital Offset Printing Plates originating in or exported from China PR imposed vide Notification No.51/2012-Customs (ADD), dated the 3<sup>rd</sup> December, 2012.
- Notification No. 33/2018-Cus (ADD), dated 01-06-2018 has been issued to seek revision anti-dumping duty on imports of Hydrogen Peroxide originating in or exported from Bangladesh, Taiwan, Korea RP, Indonesia, Pakistan and Thailand by amending the notification No.28/2017-Customs (ADD) dated 14<sup>th</sup> June, 2017.

- Notification No. 11/2018-Central Tax (Rate), dated 28.05.2018 issued to amend notification No.04/2017-Central Tax (Rate) dated 28.06.2017 so as to notify levy of Priority Sector Lending Certificate (PSLC) under Reverse Charge Mechanism (RCM).
