**2. Document download:** Tender documents may be downloaded from Central Public Procurement Portal at <http://eprocure.gov.in/eprocure/app>. Aspiring Bidders who have not enrolled/registered in e-procurement should enroll/register participating through the website <http://eprocure.gov.in/eprocure/app>. The portal enrolment is free of cost. Bidders are advised to go through instruction provided at Annexure-VI regarding “Instructions for online Bid Submission.”

**3. Bid Submission:** Bids shall be submitted online only at CRPP website: <http://eprocure.gov.in/eprocure/app>. Instructions for online Bid submissions are given in **Annexure VI**. Any further queries relating to the process of online bid submission or queries relating to CPP Portal in general may be directed to the CPP Portal Helpdesk.

**4.** Service provided have to follow the “**terms and conditions**” provided in **Annexure-I**. The tender shall be submitted online in two parts, *viz.*, technical bid and financial bid as in **Annexure-II** and **Annexure-V** respectively. The bidder should sign Annexures I, II, III and Tender Acceptance letter in the form as in **Annexure IV and upload them in the CPPP**. The bidder should quote their price only in **BOQ** format downloaded from the site. Sample BOQ is given in **Annexure-V**. All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. **The offers submitted by Fax/email/post, etc. shall not be considered.**

**5.** A bidder who has downloaded the tender from the Central Public Procurement Portal at <http://eprocure.gov.in/eprocure/app> shall not tamper/modify the tender form including downloaded price bid template in any manner. In case, if the same is found to be tampered/modified in any manner, tender will be completely rejected.

**6.** Earnest Money Deposit (EMD) or bid security of Rs. 2,500/- (Rupees two thousand and five hundred only) shall be submitted by the bidder in the form of Account Payee Demand Draft or Fixed Deposit Receipt or Bank Guarantee from any of the Commercial Banks in India, drawn in favor of “Pay & Accounts Officer, CGST” payable at Ernakulam on or before Technical Bid opening date/time as mentioned in Critical Date Sheet. Tenders will be treated as non-responsive and will be rejected, at the initial stage itself, if hard copy of EMD is not received on or before opening of Technical Bid.

TERMS AND CONDITIONS OF THE TENDER NOTICE

1. The service provider should be a proprietorship/partnership registered firm/company and the vehicle(s) should be registered in Kerala.
2. The garage of the agency/firm should be located within 8 KMs from the office of the Directorate General of Goods & Services Tax Intelligence, Kozhikode Regional Unit, Room No. 5, Ground Floor, C. R. Building, Mananchira, Calicut - 673 001.
3. The copy of the RC of the vehicle offered on hire should be uploaded with the technical bid.
4. The contract for providing vehicle on monthly hire basis will be given to the *i.e.*, **the person who has quoted the lowest monthly charges (exclusive of GST)** while meeting all the terms and conditions given in the tender document. To safeguard against failure by the successful service provider in providing the vehicle, this office may empanel other service providers who are prepared to provide service as per same terms and conditions as that of L-1 bidder. In case quality of service by the service provider is not found adequate, the directorate may terminate the contract after giving One month's notice. In case of such termination, services of other empaneled Service Providers may be utilized.
5. This office reserves the right to revise the requirements of vehicles being hired.
6. The vehicle deployed for the Department should not be older than three years and shall have clean seat covers and interiors in top running condition. It should be comprehensively insured and should carry necessary permits/clearance from the Transport authority or any other concerned authority. The vehicle should also carry necessary pollution certificates issued by the competent authority.
7. The vehicles shall be exclusive use of this Directorate and should not be used by the service provider for any other purpose.
8. The vehicle shall be made available on all days including Saturday, Sunday & Holidays, if required.
9. For the purpose calculating 2000 KMs in a month, the mileage shall be reckoned from the point of reporting for duty to the point of vehicle release. No mileage will be allowed to the drivers for lunch/breakfast or for drawal of petrol/diesel/CNG, etc.
10. LPG cylinders should not be used for running the vehicle in any case.
11. The service provider shall provide name and address of the drivers. The drivers deputed for service of this Directorate should not have any Police records/Criminal cases against them. Service provider should make adequate enquiries about the drivers before deputing them for serving this Directorate. The driver(s) deputed on duty should carry valid driving license in original. They should also not have been involved in negligent driving.
12. The drivers of the vehicle should be professional drivers and should be fully conversant with the roads and routes of Kozhikode (Calicut) and surrounding

areas. The driver should possess valid driving license to drive the commercial vehicles in their names. The drivers must be proficient in speaking local languages, well mannered, courteous, healthy personal habits and should always carry a mobile phone with him.

13. The service provider should ensure that they have arrangement for establishing contact and round the clock service. The owner/firm should be available round the clock on his direct telephone (office as well as residence) so as to respond to the call for vehicles in emergent cases. The mobile number must also be given.
14. The Directorate shall not be responsible for any challan, loss, damage or any accident of the vehicle or to any other vehicles or for the injury of the driver or to any other third party. The loss of damage or legal expenses on this account shall be bore by the service provider.
15. In case any breakdown of vehicle on duty, he service provider shall make arrangement for providing another vehicle. In such a case, mileage from garage to the point of breakdown would not be paid.
16. During the period of operation, the driver should not ordinarily be changed unless requested by the Directorate General of Goods and Services Tax Intelligence, Kozhikode Regional Unit. Any driver not acceptable to the Directorate would have to be changed by service provider.
17. A daily record indicating time and mileage for each vehicle shall be maintained in a log book which should be submitted to the concerned officer in Directorate General of Goods and Services Tax Intelligence, Kozhikode Regional Unit for scrutiny and process for payment of the bills.
18. All expenses relating to salary, allowances and provident fund of the driver shall be borne by the Service Provider. Like-wise, all expenditure related to the vehicle including fuel upkeep insurance, maintenance & fuel, etc. will also be borne by the Service Provider.
19. The Service Provider shall undertake to indemnify the department against all damages/charges arising on account of or connected with the negligence of the service provider or his staff or driver or any person under his control whether in respect of accident/injury to the person or damages to the property of any member of the public or any person or in executing the work or otherwise and against all claims and demand thereof.
20. If any vehicle does not report for duty on any day(s) or the driver reports late or for violation of any other provision of the tender, then an amount calculated on pro-rata basis per day shall be deducted from the monthly bill of that vehicle. The service provider shall also be liable to a penalty of Rs.1000/- per day per vehicle for each such incident.
21. If the vehicles are not provided from the desired location, a penalty up to Rs.1000/- per day per vehicle can be imposed besides termination of contract.
22. The service provider shall provide the vehicle as per the terms of the contract/tender during the entire period of contract. In emergency and rare circumstances, this condition can be waived by the Directorate temporarily.

23. GST at the applicable rate along with monthly charges will be paid by the Department. Proof of payment of GST will be required to be submitted periodically by service provider to the Directorate.
24. The hire charges quoted will be a fixed monthly rental charge inclusive of all expenses like fuel, salary of driver, driver bata, maintenance of vehicle, insurance, etc., but exclusive of GST payable, if any. In the event of using the vehicle in excess of 2000 KMs in any month, an additional amount per each extra KM, over and above 2000 KMs in that month, will be paid at the rate of Rs.13/- per km along with applicable GST.
25. On acceptance of bid, the service provider has to submit performance guarantee of an amount equivalent to 5% of the value of the entire period of the contract of 12 months in the form of Bank Guarantee from a Nationalized Bank in favour of **Additional Director General of GST Intelligence, Kochi Zonal Unit** at the time awarding the contract. The performance Guarantee should remain valid for a period of sixty days beyond the date of completion of the contract.
26. During the period of this agreement, any matter which has not been specifically covered by this agreement shall be decided by the Competent Authority of this Directorate whose decision shall be final.
27. No conditional bids shall be entertained by this Directorate & conditional bids will be rejected summarily.
28. In case of any dispute of any kind and in any respect whatsoever, the decision of the Directorate shall be final and binding.
29. This Directorate reserves the right to require fulfillment of other condition, not expressly mentioned, which are consistent with use of vehicles on hire by this office.
30. Contract can be terminated by either party prematurely by giving advance notice of one month.

**INSTRUCTIONS FOR ONLINE BID SUBMISSION**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at <http://eprocure.gov.in/eprocure/app>.

**REGISTRATION**

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify/ nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

**SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.

- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

## **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents"" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

## **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.

- 3) Bidder has to select the payment option as “offline” to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- 5) Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BoQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. Bidders are required to download the BoQ file, open it and complete the coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.
- 6) The server time (which is displayed on the bidders’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 7) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done. Any bid document that is uploaded to the server is subjected to symmetric encryption using a system generated symmetric key. Further this key is subjected to asymmetric encryption using buyers/bid opener’s public keys. Overall, the uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 9) Upon the successful and timely submission of bids (i.e. after Clicking “Freeze Bid Submission” in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
