4. EMD of successful bidder will be returned after they submit proof of full payment of quoted tender value. It may be adjusted as part of the total payment at the discretion of disposal committee. No interest shall be payable on such EMD. The EMD shall be forfeited if the tenderer unilaterally withdraws, amends, impairs or derogates from his offer in any respect within the period of validity of his offer.
5. The EMD of unsuccessful bidder will be returned on finalization of entire tender process. No interest will be paid on EMD amount.
6. The highest bidder qualifying in the bid process would be given the permission to lift the things from the office "As is where is condition".
7. The disposal / sale of goods, as per Annexure – A, will be carried out in a sealed bid process.
